Dear Ratepayer

An important change is coming to Monash and we want to hear your feedback.

The food and garden waste bin collection is switching to a weekly service.



From August 2022, food and garden waste (green lid) bins will be collected **every week** and rubbish (red lid) bins will be collected **every two weeks**.

Residents are being notified of this change, however we would appreciate your support in checking that tenants at your property have received this information.

Why are we making this change?

There are two main reasons for this change; to reduce our environmental footprint and to save ratepayers substantial costs in reduced landfill levy payments.

Over the past few years, we've all seen and read the stories of mountains of landfill piling up. This is unsustainable and we must take immediate steps to reduce the amount of waste we are generating.

Estimations are that more than 50% of our landfill is food and organic waste. By simply putting food scraps into the food and garden waste bin, you can help us to eliminate half of all the landfill we generate – it is that simple! You will also be helping to reduce the landfill levies we have to pay, which have significantly increased.

Who does this change apply to?

This change applies to properties that have a food and garden waste bin and a rubbish bin allocated to individual addresses.

For apartment buildings, or properties that share bins between tenants, there will be no change and the rubbish bin will continue to be collected weekly.
