Summary

Each year, Council prepares an annual budget which outlines how we will deliver services and programs to our community. The budget covers things like managing waste, upgrading infrastructure, community facilities and parks, operating libraries, recreation centres, events and festivals, and services to people at all stages of life.

Our aim is to deliver a fair and financially responsible budget which responds to the needs of our community and focuses on delivering critical projects to ensure ratepayers get the best value from their investment.

Before we start to work on the budget, we seek ideas and feedback from the community which help us prioritise the types of projects and services they want Council to consider.

Monash Council recognises that the involvement of the community in making decisions and plans is fundamental to good governance. The Monash community is culturally diverse and engaged, rich with experience and expertise, whose participation is valued by Council.

This year, two phases of engagement will occur:

- Stage one focused on garnering community input into our operations and priorities. It also provided the opportunity hear any special projects from the community. This phase of engagement occurred over October, November and December 2022. *This document reports on the findings from this round of engagement.*
- Stage two will be targeted engagement through a deliberative process.

Stage one engagement overview

The aim of the stage one of engagement was to:

- Provide the Monash community the opportunity to priorities funding for services/projects;
- Identify community priorities for discretionary and non-discretionary funding; and
- Use feedback from the survey to provide a degree of consensus where funding should be directed.

Methods of engagement

A dedicated online site was established to record feedback, using Council's engagement platform, *Shape Monash*. The site was launched on 28 October 2022 and closed on 13 December 2022.

There are three areas the community engagement platform focussed on in stage one:

- 1. Feedback on our operational budget, this being gathering feedback on how council distributes funds across its portfolio.
- 2. Thoughts on important community priorities, based on topics generated from the community when the long-term Community Vision and four-year Council Plan was developed in 2020. This engagement provides a check on changing community priorities over the past two years. (See section 2: Community Priorities page 7)
- 3. Specific community priorities and projects primarily this is an opportunity to talk about specific projects of importance to the community.

Council invited the Monash community to participate by:

- Interacting directly with the online platform.
- Talking to officers at a 'listening post' or by reaching out to them directly. Six 'Listening Posts' were programmed over a four (4) week period, with one being cancelled due to poor weather. These posts were held on different days, times and locations across the municipality giving the Monash

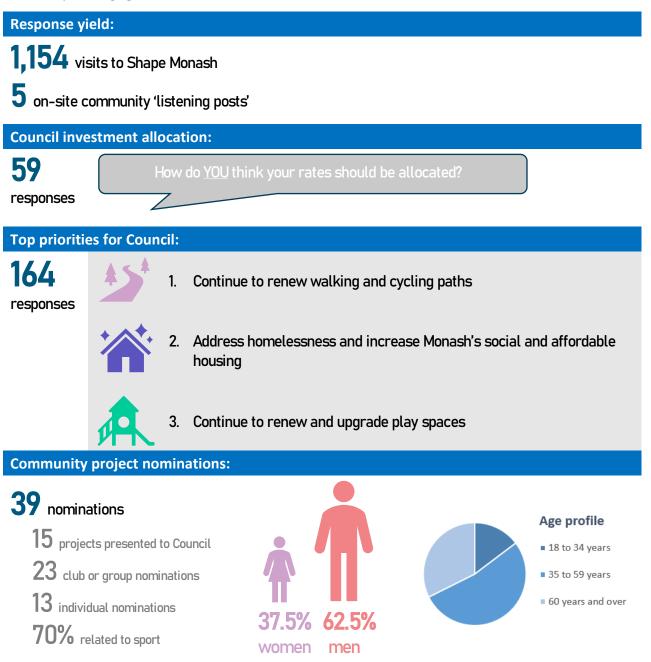
community the opportunity to participate and engage directly with Monash staff on how they would like to shape the 2023-24 budget.

- Feedback forms were also available for those who wished to make comment, or provide feedback and suggestions to Council.
- Councillors were invited to attend with officers to hear from the community and seek input into our 2023/24 budget.

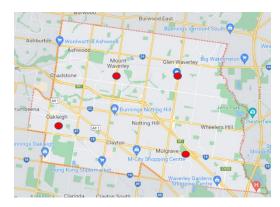
Signification promotion of the engagement occurred including via:

- Articles in the monthly Council bulletin that is delivered to every household in Monash
- Information through Council's enewsletters
- Direct promotion through our Community Services clients
- Local advisory groups
- A targeted social media campaign

Summary of engagement



Listening posts



Five Listening Posts were coordinated across November and December 2022 (see map). The Listening Posts were an opportunity for community to discuss any matter with officer, with additional specific consultation around the three APP topics (operational budget allocation, long term Monash priorities, and community driven specific project ideas).

Engagement feedback on the budget was entered into Shape Monash by officers or the respondents, and the results are amalgamated in the engagement findings presented in the next three sections of this report.

17/11/22	Oakleigh – indoors at Oakleigh Shopping Centre and outdoor at Eaton Mall	 There was limited take up of engagement with during this timeslot, presumably as it coincided with school pick-ups, after-school activities and people generally seeming as they were rushing. Recommend scheduling a later time and having additional signage. Much of the feedback received related to non-budget issues 	
24/11/22	Mount Waverley - Hamilton Square	 Good amount of foot traffic, with a generally older demographic participating in the consultation. Officers were accompanied by two councillors. 	
27/11/22	Mulgrave Farmers Market and Sunday Craft Market	 Market attendees seemed to be receptive to the engagement activity. A Monash-branded marquis/tent was used providing clear indication of it being a sanctioned council event. Main conversation topics related to environmental initiatives. 	
6/12/22	Glen Waverley - The Glen Forecourt	There was limited foot traffic in this location.Weather was dry and warm.	
12/12/22	Glen Waverley - Library Forecourt	 The 4 - 6pm timeslot was reduced to 30 minutes due to heavy rain. Minimum interaction thought to be associated to the poor weather conditions. 	

1. Operational budget –allocation of funding to Council services

Participants were asked to provide feedback on how they would like to invest their rates by reviewing the budget allocations from 2021-2022.

Background information was provided for this exercise, namely information on how Council currently distributes budgets across services (based on the proportion of \$1,000 spent across each activity in 2021-22).

The survey allowed participants to use a slider to increase or decrease spending in each operating area and reallocate funds by up to 25% for each area.

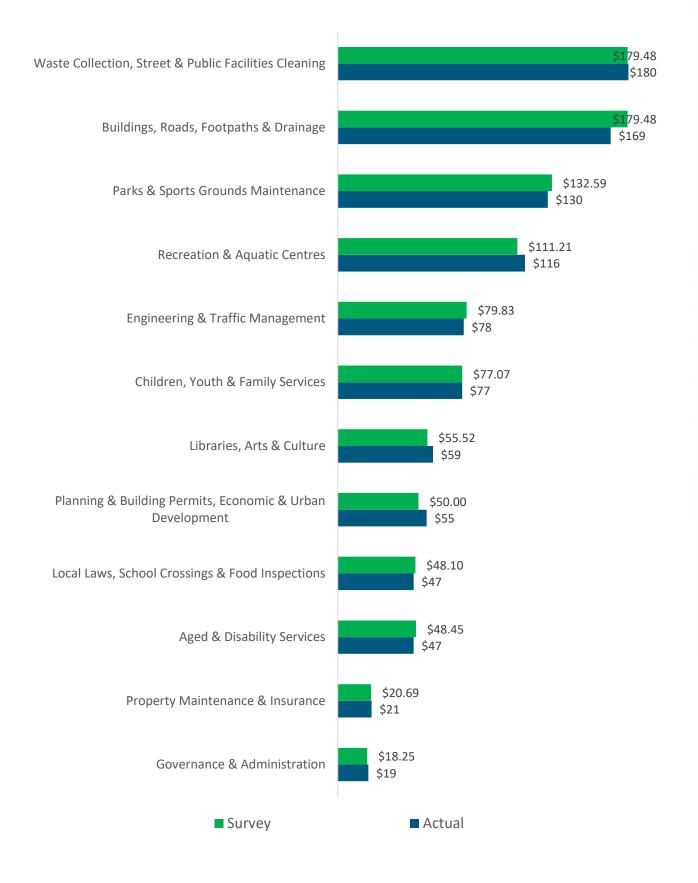
Results

Generally, the amounts recommended by the community are in line with how we are currently allocating these funds with very minor changes noted:

- A slight increase of investment in buildings, roads, footpaths and drainage (6% increase)
- A slight reduction in investment in recreation and aquatic centre (4%) with a slighting increase in investment in public parks, and sports grounds (2%).

The results are documented in Figure 2.





2. Community priorities

Participants were invited to consider the following community priorities which were based on topics generated from the community when the long-term Community Vision and four-year Council Plan was developed in 2020, these are listed in **Table 1**.

Participants were asked to choose three (3) from the following eight (8) project considerations. By limiting selection to just 3 votes, we were able to pinpoint the top priorities for Council to consider before starting work on the budget.

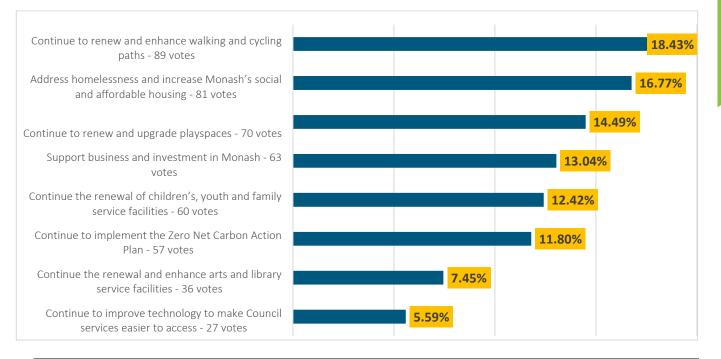

6	Support business and investment in Monash	
7	Address homelessness and increase Monash's social and affordable housing	
8	Continue to renew and upgrade playspaces	

Results

The average scores are shown in Figure 3. The top three (3) priorities the community voted on were to:

- 1. Continue to renew and enhance walking and cycling paths
- 2. Address homelessness and increase Monash's social and affordable housing
- 3. Continue to renew and upgrade play spaces

3. Nominate a project

The '*Nominate a Project*' feature provided an opportunity for the community to submit a specific budget idea or proposal for consideration on behalf of themself or a community group or organisation.

Participants were also given the opportunity to present their idea(s) to Council on Tuesday 6 December. Of the 39 submitters, 15 projects were presented at this meeting.

Results

A total of 39 submissions were received. Almost 70% of the submissions were relating to Sports and recreation or improvements to public parks and open spaces.

15 submissions were presented by submitters to Council at its meeting on 6 December 2022.

Figure 4 shows the proportion of submissions by theme. Information on the community projects by theme are presented in Table 2.

Figure 4: Overview of submission by theme

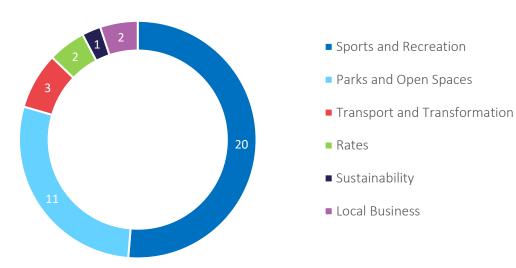
